

ONLINE POLICY PRIVACY AGREEMENT

eTurns, Inc. (eTurns or the Company), is committed to keeping any and all personal information collected of those individuals that visit our website and make use of our online facilities and services accurate, confidential, secure and private. Our privacy policy has been designed and created to ensure those affiliated with eTurns of our commitment and realization of our obligation not only to meet but to exceed most existing privacy standards

THEREFORE, this Privacy Policy Agreement shall apply to eTurns and thus it shall govern any and all data collection and usage thereof. Through the use of eTurns.com you are herein consenting to the following data procedures expressed within this agreement.

Collection of Information

This website collects various types of information, such as:

- Voluntarily provided information which may include your name, address, email address, and telephone numbers which may be used when you request information, purchase products and/or services and to deliver the services you have requested.
- Information automatically collected when visiting our website, which may include cookies, third party tracking technologies and server logs.

Please rest assured that this site shall only collect personal information that you knowingly and willingly provide by way of surveys, completed forms, and emails. It is the intent of this site to use personal information only for the purpose for which it was requested and any additional uses specifically provided on this site.

We may also gather information about the type of browser you are using, IP address or type of operating system to assist us in providing and maintaining superior quality service.

Social Media Features and Single Sign-on

The Company's Web site may *use* media features, such as the Facebook "like" button (Social Media Features"). These features may collect your IP address and which page you are visiting on the Company's Web site, and may set a cookie to enable the feature to function properly. You may be given the option by such Social Media Features to post information about your activities on the Company's Web site to a profile page of yours that is provided by a third party social media network in order to share with others within your network. Social Media Features are either hosted by a third party or hosted directly on the Company's Web site. Your interactions with these features are governed by the privacy policy of the company providing the relevant Social Media Features.

It is highly recommended and suggested that you review the privacy policies and statements of any website you choose to use or frequent as a means to better understand the way in which other websites garner, make use of and share information collected

Mobile applications.

Without limiting the generality of this Privacy Statement, in addition to information gathered through its Web sites or submitted to its Services, eTurns may obtain information through applications (“Mobile Applications”) that Customers or their authorized individuals (“Users”) download to, and run on, their mobile devices (“Devices”). Mobile Applications provided by eTurns may obtain information from, or access data stored on, Users’ Devices to provide services related to the relevant Mobile Application. For example, a Mobile Application may: access a camera on a User's Device to enable the User to upload barcodes to the Services; access calendar information on a User's Device to enable the User to source information submitted by the User to the Services; or to access the geographic location of a User's Device to enable the User to identify locations submitted by the User to the Services. Information obtained to provide Mobile Application services may include information obtained in preparation for anticipated updates to those services. Mobile Applications may transmit information to and from Devices to provide the Mobile Application services.

Mobile Applications may provide eTurns with information related to Users’ use of the Mobile Application services, information regarding Users' computer systems, and information regarding Users’ interaction with Mobile Applications, which eTurns may use to provide and improve the Mobile Application services. For example, all actions taken in a Mobile Application may be logged, along with associated information (such as the time of day when each action was taken). eTurns will not share anonymous data about these actions with any third parties.

Customers may configure eTurns Mobile Application services, and the information accessed or obtained by the Mobile Application on a User’s Device may be affected by the Customer’s configuration. Information accessed or obtained by the Mobile Application on a User's Device may be accessible to the Customer and its organization, depending on the intended functionality of the Mobile Application. eTurns may provide updated versions of its Mobile Applications. If your mobile device's settings permit, those updates will be downloaded and installed automatically on your mobile device. By installing an eTurns Mobile Application on your mobile device, you consent to the downloading and updating of that Mobile Application.

Notices and contractual terms related to a particular Mobile Application may be found in the End User License Agreement or relevant terms of service for that Application. The Company encourages you to review the End User License Agreement or relevant terms of service related to any Mobile Applications you download, install, use, or otherwise interact with to understand that Mobile Application's information practices. The Mobile Application's access to information

through a User's Device does not cause that information to be "Customer Data" under eTurns Master Agreement with the Customer or under this Privacy Statement, except as follows: To the extent that a User uses a Mobile Application to submit electronic data and information to a Customer account on our Services pursuant to the Customer's Master Agreement with eTurns (or a similar agreement that governs the Customer's subscription(s) to eTurns Services), that information constitutes "Customer Data" as defined in such agreement, and the provisions of that agreement with respect to privacy and security of such data will apply.

Use of Information Collected

eTurns, Inc. may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from www.eTurns.com. eTurns may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered. eTurns does not now, nor will it in the future, sell, rent or lease any of our customer lists and/or names to any third parties.

eTurns may deem it necessary to follow websites and/or pages that our users may frequent in an effort to glean what types of services and/or products may be the most popular to customers or the general public.

eTurns may disclose your personal information, without prior notice to you, only if required to do so in accordance with applicable laws and/or in a good faith belief that such action is deemed necessary or is required in an effort to:

- Remain in conformance with any decrees, laws and/or statutes or in an effort to comply with any process which may be served upon eTurns, Inc. and/or our website;
- Maintain, safeguard and/or preserve all the rights and/or property of eTurns; and
- Perform under demanding conditions in an effort to safeguard the personal safety of users of eTurns.com and/or the general public.

Public forums, refer a contact, and Customer testimonials

eTurns posts a list of Customers and testimonials on the Company's Web site that contain information such as names and titles. eTurns obtains the consent of each Customer prior to posting any information on such a list or posting testimonials.

Unsubscribe or Opt-Out

All users and/or visitors to our website have the option to discontinue receiving communication from us and/or reserve the right to discontinue receiving communications by way of email or newsletters. To discontinue or unsubscribe to our website please send an email that you wish to

Links to Other Web Sites

Our website does contain links to affiliate and other websites. eTurns does not claim nor accept responsibility for any privacy policies, practices and/or procedures of other such websites. Therefore, we encourage all users and visitors to be aware when they leave our website and to read the privacy statements of each and every website that collects personally identifiable information. The aforementioned Privacy Policy Agreement applies only and solely to the information collected by our website.

Security

eTurns shall endeavor and shall take every precaution to maintain adequate physical, procedural and technical security with respect to our offices and information storage facilities so as to prevent any loss, misuse, unauthorized access, disclosure or modification of the user's personal information under our control.

eTurns also uses multiple Secure Socket Layer (SSL) certificates to encrypt all data transmission from our users to our servers and back to our users for authentication and communications in an effort to build users' trust and confidence in the internet and website use by providing simple and secure access and communication of any personal information. Certain information is also encrypted at rest on our servers.

Changes to Privacy Policy Agreement

eTurns reserves the right to update and/or change the terms of our privacy policy, and as such we will post those change to our website homepage at eTurns.com, so that our users and/or visitors are always aware of the type of information we collect, how it will be used, and under what circumstances, if any, we may disclose such information. If at any point in time eTurns decides to make use of any personally identifiable information on file, in a manner vastly different from that which was stated when this information was initially collected, the user or users shall be promptly notified by email. Users at that time shall have the option as to whether or not to permit the use of their information in this separate manner.
